OD Review Goals

- To determine if the current structure and resource allotments of the NICHD OD best meet NICHD needs, or if adjustments would enhance effectiveness and workflow
- To determine if the current NICHD OD functions best align with the goals of NICHD, or if any functions currently in OD would fit better elsewhere and vice versa

OD Review: Background

- Office of Director has unique position and function
- Evaluation of structure and function important to align and improve functionality
- Restructuring of NICHD in 2012 did not include OD
 - OD historically performed oversight of DER, NICHD Deputy Director oversaw DER
 - 2012: NICHD Associate Director for Extramural Research created
 - However, 2012 restructuring did not extend to all DERrelated functions/structures in OD

 - National Institute of Mental Health (NIMH)
 - National Institute on Drug Abuse (NIDA)
- Comparisons
 - Organizational composition
 - FTEs
 - Resources

Benchmarking Comparisons

- Compared to Institutes with similar budgets, NICHD has OD staff of similar size
- However, many different configurations for OD offices; not always an "apples to apples" comparison
 - Some combined Office of Science Policy, Analysis & Communication, some had stand alone Office of Communications
 - Some had offices that don't exist at NICHD like Office of AIDS, Office of Translational Research, or Office of Technology Development and Coordination
- Different number of FTEs vs contract workers
- Function and structure of OD offices differs across Institutes and Centers
