[DiPHR](#) invites applications for the position of staff scientist in the [Office of the DiPHR Director](#) (OD). The OD conducts epidemiologic research focusing on reproductive and perinatal endpoints to identify etiologic mechanisms aimed at maximizing health and preventing disease. Research within the OD is closely aligned with NICHD's [strategic plan](#) (PDF 2.3 MB) and with DiPHR's population-based research on health during pregnancy. Staff scientists in the OD make high-level contributions to the division's active research programs, publish in scientific journals, and contribute to the OD's mentoring and professional service missions.

Eligible candidates will possess an earned doctorate in epidemiology or a closely related field (e.g., maternal and child health, public health) and additional years of postdoctoral experience relevant to the position. The ideal candidate will have excellent communication skills (both oral and written), strong quantitative skills including statistical methods commonly used in epidemiology (e.g., longitudinal data analysis, hierarchical modeling), experience and research interests in the areas of reproductive and/or perinatal epidemiology, maternal and child health in diverse populations, and the early origins of health as evidenced by training, work experience, and publications in peer reviewed journals.

To apply, email a cover letter describing research interests and professional accomplishments, *curriculum vitae*, and three letters of reference to Dr. Pittman. Review of applications will begin on May 1, 2023, and will continue until the position is filled.

Appointees may be U.S. citizens or resident aliens. A full benefits package is available, including retirement, health insurance, flexible spending accounts, life insurance, annual and sick leave, and Thrift Savings Plan (401K equivalent). The position is subject to a background check.

Federal agencies may request information regarding the vaccination status of selected applicants for the purposes of implementing workplace safety protocols, such as protocols related to masking, physical distancing, testing, travel, and quarantine.
